



## NM-COROS Registration Home & Status

Welcome to the New Mexico Charitable Organization Registration Online System (NM-COROS). Within this site, you will be able to fulfill the registration requirements as a charitable organization which exists, operates or solicits contributions in the state of New Mexico. You will be able to enter all information pertaining to your organization and upload PDF versions of required documents.

After **every tax year completes** for the charity, you must return to NM-COROS before the tax year due date or longest extension and:

- Verify and update previously entered information.
- Enter financial information for the completed tax year.
- Upload or mark as being mailed any required documents.
- **Submit registration for tax year.**

*NM-COROS reporting is based on the **IRS Tax Year**.  
 A **Tax Year** is equal to the year for which a calendar/fiscal accounting period **begins**.*
